Services Provided

The Stylist agrees to provide any of the following services to the Client:

1. **Wardrobe Audit:**
 - Wardrobe consultation
 - Style assessment
 - Body shape assessment
 - Silhouette assessment
 - Wardrobe Edit
2. **Personal Shopping:**
 - Shopping for specific items
 - Seasonal wardrobe updates
 - Accessory selection
 - Return and exchange services
3. **Personal Styling:**
 - Outfit coordination
 - Special event styling
 - Lookbook building (photos/videos)

Terms and Conditions

1. **Service Fees:**
 - Wardrobe Audit: \$195 / hour
 - Personal Styling: \$195 / hour
 - Personal Shopping: \$195 / hour
 - Long distance fee for home appointments: \$30 (10-20 km area) \$50 (20 - 40km area)
 - Payment Method: cash, e-transfer

2. Payment Clause:

- **New Client Retainer:** A non-refundable initial retainer fee of \$390 (2 hrs value) is due at the time of booking the first appointment. The funds will apply to the first appointment
- **Hourly Rate:** The Stylist charges an hourly rate of \$195/hour for all the services provided.
- **Advance Payment:** All services must be paid for in advance. Payment for the estimated hours or packages must be made prior to the commencement of services.
- **Payment Methods:** Accepted payment methods include cash, e-transfer

3. Non-Refund Clause for Provided Services:

- Services that have already been provided are non-refundable. Once a service has been rendered, the Client is not entitled to a refund for those services.

4. Non-Refundable Clause for Gift Cards:

- Gift cards purchased for the Stylist's services are non-refundable and cannot be exchanged for cash.

5. Appointment Scheduling:

- All appointments must be scheduled in advance.
- Cancellations must be made at least 24 hours in advance. Late cancellations or no-shows may be subject to a one-hour (\$195) fee.

6. Confidentiality:

- The Stylist agrees to keep all personal and financial information of the Client confidential.
- The Client agrees not to disclose any proprietary information regarding the Stylist's methods or business practices.

7. Liability:

- The Stylist will not be held responsible for any allergic reactions or injuries resulting from the use of recommended products.
- The Client is responsible for providing accurate size and preference information.
- The Stylist will not be held liable for the quality, durability, or performance of clothing and accessories purchased or recommended. This includes, but is not limited to, any damage, defects, or the clothing falling apart after purchase. The Client is responsible for inspecting all items upon purchase and addressing any issues directly with the retailer.

8. Termination:

- Either party may terminate this Agreement at any time with 5 days written notice.
- In the event of termination, the Client will be responsible for payment of all services rendered up to the termination date.

9. Governing Law:

- This Agreement shall be governed by and construed in accordance with the laws of the Province of Alberta.
